



**CITY OF CLAREMONT
2024-2025 CITY COUNCIL APPOINTMENTS**

Citizen participation is encouraged in the Claremont City government decision-making process. Claremont has five commissions, which advise and assist Council in dealing with specific problems. These advisory bodies gather pertinent information, hear arguments, weigh values, and make recommendations to Council about what they have considered to be the best action. Qualifications for service on a commission are: Claremont residency, with certain exceptions, a strong interest in the work of the commission and the community, and the ability to give generously of one's time when serving. Terms of office are for up to four years, and a commissioner may be reappointed for an additional term for a maximum of 8 years of continuous service.

Claremont has a nine-member Sustainability Committee, the purpose of which is to provide broad oversight of implementation of the Sustainable City Plan. Desirable qualifications: Supportive of the goals of the Sustainable City Plan and be knowledgeable in sustainability matters and/or represent a significant stakeholder group that is directly impacted by sustainability measures.

The Public Art Committee, established in 2016, consists of seven members, two of which shall be art professionals, and at least one shall be appointed from the Architectural Commission. The Committee provides advice regarding the public art program, artist selection, artwork review, conservation, etc.
