Mountain Avenue Complete Streets Project

The City of Claremont continues to work toward the completion of the Mountain Avenue Complete Streets Project. This project was initially brought before the Traffic and Transportation Commission (TTC) in October 2021 as part of the City's roadway maintenance program. At that time, the TTC suggested to staff a number of improvements that were above and beyond basic roadway The extensive improvements maintenance. required that Mountain Avenue be reviewed with consideration for complete streets features/ components per the City's Complete Streets Policy. Staff subsequently took an item to the City Council in January 2023 to award a design contract to KOA Corporation. The scope of the design contract was to integrate Complete Streets components including curb extensions; raised crosswalks; pedestrian crossings with rapid flashing beacons, a road diet (north of Foothill Boulevard); Americans with Disabilities Act (ADA) improvements; a Class I bike lane (Butte Street to Harrison Avenue); and Class II bike lanes from Base Line Road to Bonita Avenue on Mountain Avenue. Staff also asked KOA to consider the recommendations from a Complete Streets Safety Assessment (CSSA) conducted by UC Berkeley on Mountain Avenue. Since then, City staff has held public meetings regarding the Mountain Avenue Complete Streets Project eight times. This public process includes five TTC meetings, two City Council meetings and one neighborhood meeting.

Currently, staff is working with KOA to complete the plans to the 60% stage, with the anticipation of completing the design by early November 2024.



Staff anticipates having a shovel-ready Mountain Avenue Complete Streets project ready in November in order to apply for the next round of SB1 Local Partnership Program (SB1 LPP) Grant funding. In 2018, staff was successful in obtaining a SB1 LPP Grant Award in the amount of \$7,000,000 to bridge the gap in funding for the Foothill Boulevard Improvement Project. Staff is hopeful that the SB1 LPP funds will be able to assist with construction of the Mountain Avenue Complete Streets project in a single phase, if

City Council Election - November 5, 2024 A General Municipal Election will be held on November 5, 2024 to elect two members of the

Claremont City Council. Voters in Districts 1 and 5 will elect by-district City Council representatives. The City transitioned from at-large voting (citywide) to a by-district election system in 2019, creating five geographic district areas. The City redistricted in 2022 following the Census. The first by-district election was conducted for Districts 1 and 5 in November 2020. City Council terms are for four years.

In addition to voting for City Council Districts 1 and 5, Claremont voters will be voting on Claremont Unified School District trustees for Districts 2 and 5, a variety of County and State elected representatives and measures, and the President of the United States.

The Los Angeles County Registrar Recorder's Office will begin mailing ballots starting October 7 and official sample ballot pamphlets will be mailed on October 15. Vote-by-Mail ballot drop-off boxes are located at the Alexander Hughes Community Center and Claremont Helen Renwick Library. County voting centers will open 10-14 days before the election. A list of vote centers will be released by the County 30 days before the election. The last day to register to vote in the November 5 election is October 21, 2024.

Rental Assistance Funding Available

The City is now accepting applications for the Claremont Temporary Housing Stabilization and Relocation Program Cycle 2. This program is designed to assist Claremont renters who are either income-qualified OR are in need of "Emergency Rental Assistance" due to:

- Qualifying as extremely low-, very low-, or low-income;
- Experiencing certain qualifying exigent circumstances (e.g., illness, job loss, etc.);
- Needing to move as a result of a no-fault eviction; and/or a rental increase imposed on an already rent-burdened household or a rental increase that would result in a household becoming rent-burdened.

The Program is also designed to provide financial assistance to housing providers in Claremont who may wish to make improvements or upgrades to their property and is designed to provide an incentive to housing providers to lease their units at or below Fair Market Rent (FMR).

City Council Adopts Two Year Budget On Tuesday, June 11, 2024, the City Council unanimously approved the Operating and Capital

Improvement Program Budget for 2024-26. The FY 2024-26 budget continues to provide the high levels of service expected in Claremont and maintains the quality programs and services that contribute to the quality of life for residents, businesses, and visitors to the city. The balanced budget not only meets the operational needs of the City but also sets aside \$1.2 million in funding to address long-term pension liabilities.

General Fund Revenue is projected to be \$35.8 million and \$36.6 million respectively for 2024-25 and 2025-26, with 60% coming from sales and property taxes. The balance is generated from other City taxes, fees for service, permits, and reimbursements. General Fund expenditures and transfers out are projected to be \$35.8 million and \$36.6 million respectively for 2024-25 and 2025-26. Expenditures are approximately 4.6% higher compared to the 2023-24 General Fund Expenditures

The proposed 2024-26 Capital Improvement Program Budget includes funding in the amount of \$12,141,045 for a variety of street and sidewalk maintenance, sewer repairs, storm drain and water infiltration projects, accessibility improvements, cemetery expansion, and traffic signal modification projects, among others. Capital Improvement funding comes from a number of special dedicated and restricted funds.

Community Safety and School Safety



With Claremont schools back in session, the Claremont Police Department will be strictly enforcing traffic laws in each of the school zones to ensure the safety of students, staff, and parents. Drivers are reminded to be especially vigilant before and after school hours when children are walking and riding their bikes.

Here are several recommendations on ways drivers can help to keep our kids safe:

- Give yourself plenty of time to get to school and drop off your child. Rushing can cause unsafe behavior and speeding.
- Slow down. The speed limit in school zones is 25 mph.
- Come to a complete stop at stop signs. Before proceeding, carefully check for children on the sidewalks and in the crosswalks.
- Drop off and pick up your kids in your school's designated areas, not the middle of the street. Every vehicle has blind spots. Please check for children on sidewalks, in driveways, and around your vehicle before proceeding.
- Watch for children on bicycles. Slow down when passing bicyclists and allow at least three feet between your vehicle and the bicyclist. Please ensure that your child wears a helmet while riding their bicycle to school.
- Stay alert and put your phone away. Using a handheld electronic device while driving is against the law.
- Talk to your teen about vehicle safety. Car crashes are the leading cause of death for teenagers in the United States.

Please remember to follow all school drop off and pick up procedures. Claremont Police Officers will be patrolling the school zones and the streets surrounding the Claremont school zones to remind drivers to drive safely. We are looking forward to a safe and healthy school year for students, staff, and parents!

Short Term Rentals Survey

The City is considering a Short-Term Rental Ordinance that would regulate shortterm rentals of homes in Claremont. Short-term rentals are rentals of less than 30days and typically rent through a booking website like Airbnb and Vrbo. Currently, the City does not allow home rentals under 30 days in duration. To gauge residents concerns in allowing short-term rentals, the City is inviting residents to take a survey. Housing Development Updates



La Puerta Development Update

On August 12, 2024, Trumark Homes informed the City of its intent to pursue its original 56-unit residential housing project.

For over two years, the City worked with Trumark Homes to revise a plan for a 56-unit townhome development on the site of the former La Puerta Intermediate School. The Claremont Unified School District owns the property. The School District designated the site as surplus property and put it up for sale in 2013. The Claremont Unified School District entered into an escrow agreement with Trumark Homes for the property in 2020.

Trumark Homes announced in April of 2024 that it was moving forward with a 91-unit residential project with 20% affordable units using the State's "Builder's Remedy" law. Builder's Remedy projects are subject to less restrictive zoning requirements and generally must be approved under a streamlined approval process with fewer public hearings. With the most recent announcement, City staff will return to moving the 56-unit project through the Commission and City Council review process.

The Architectural Commission reviewed the preliminary design of the 56-unit project on February 28, 2024. The draft Environmental Impact Report (EIR) for the 56-unit project was circulated to the public in July 2023. The 45-day public comment period on the DEIR ended in September of 2023. The Final EIR will be considered for certification by the Planning Commission and City Council in the upcoming public hearings. The City Council will consider the Planning Commission's recommendation and make the final decision on whether to approve the 56-unit project.
