

# College Avenue at Green Street Bike and Pedestrian Improvements Project

The City will begin construction on the College Avenue at Green Street Bike and Pedestrian Improvements Project in March 2024. This project will provide bicycle and pedestrian improvements on College Avenue by relocating the existing traffic signal currently located at Kirkwood Avenue to the intersection of College Avenue at Green Street. For safety purposes, the traffic signal at Kirkwood Avenue will remain in place until the traffic signal at Green Street can be constructed and activated. In addition, Americans with Disabilities Act (ADA) improvements will be made at the intersections of Kirkwood Avenue and Green Street including curb extensions, count down pedestrian leads, hands-free push buttons to activate the pedestrian crossing, and pedestrian lead timing. Additionally, the roadway will be re-striped and resurfaced. This project is being coordinated with the Claremont Unified School District and is anticipated to be completed in June 2024.

### Thompson Creek Trail Pedestrian Crossing Project

Improvements to the Thompson Creek Trail crossing at Mountain Avenue began in February 2024. This project includes pedestrian safety and driver awareness improvements at the trail crossing at Mountain Avenue. The project includes new signage and striping supporting pedestrian, equestrian and bicycle transportation. New striping improvements include rumble strips, "TRAIL XING" pavement markings, bicycle share the road markings or "Sharrows" and speed limit pavement markings. New warning signs will be installed to alert drivers of the presence of pedestrian, bicyclists and equestrian use. The project also includes additional safety components, such as driver feedback speed signs and rectangular rapid flashing beacons. These additional components will be installed as part of a second phase of this project, pending Los Angeles County Department of Public Works approval. ### City E -Bike Program Success

The Claremont E-Bike Rebate Program and GoSGV Program subsidy has added over 150 new e-bikes to the streets of Claremont. With these programs, residents have been able to diversify their local mobility options and reduce their reliance on cars. The E-Bike Rebate Program is now fully expended, but there are still a limited number of GoSGV e-bike subsidies available. ### IC2 Program

The City recently committed \$400,000 in small business grants to assist Claremont small businesses impacted by the pandemic. In addition to the grant, the City and Innovate Claremont launched the on-going Innovate Claremont Internship Program (IC2), that creates a partnership between Claremont businesses and organizations, and the highly talented students at the Claremont Colleges. The IC2 Program is available to businesses regardless of if they received a grant or not. Innovate Claremont will assist businesses in creating a job description and finding an intern that fits their organization's needs. ### Affordable Housing at the Old School House Apartments

As required by the City's Inclusionary Housing Ordinance, the Old School House Apartments have allocated 16 rental units for moderate-income households at affordable rates. These units have been occupied by income eligible households since April 2023. # **City Council Reaffirms Priorities For 2024-26**

On Saturday, January 27, 2024, the City Council held a Priorities Workshop to receive input from the community and provide direction to staff on work plan items for the next two years. The workshop was held prior to the development of the next budget to ensure funding is identified for new and expanded programs and projects.

At past Priorities Workshops, the City Council has directed staff to develop new projects, policies, and programs based on the feedback received through focus group meetings and a community survey. The City's E-Bike Program, DEI Training Program, Hotel-Motel Ordinance, Tenant Assistance Program, Small Business Assistance Grants, and the Accessory Dwelling Unit Grants and Design Programs were all developed through the Priorities Process. These programs have successfully addressed needs identified by the community and have expanded services for residents and businesses.

During the 2024 Priorities Workshop, the City Council reaffirmed the seven existing priorities, and directed staff to present additional information at a future City Council meeting regarding various programs, projects, and services. Staff will bring back information on tree policies and urban forest preservation, rental assistance and rental registries, first time home buyer assistance programs, and Blaisdell Ranch Preserve management options.

City staff will be preparing the 2024-26 Budget over the next few months, taking into consideration the City Council's priorities, goals, and objectives. Public meetings will take place in May and June to present the budget to the community.

### **Hotel/Motel Ordinance Update**

Last year, the City Council adopted a Hotel/ Motel Ordinance to address escalating crime around the City's hotels and motels. On January 23, 2024, staff presented the first Annual Hotel/Motel Ordinance Update Report to the City Council. The report included the 2023 Fourth Quarter Report from the City Interdepartmental Team (CIT). Since the adoption of the ordinance, the City has seen a decrease in criminal and nuisance activity near the properties and an increase in coordination between the City, the hotel operators, and the community. The Claremont Police Department has conducted several targeted enforcement operations in partnership with other law enforcement agencies resulting in multiple arrests. The CIT will publish its next Quarterly Report in April, which will report on activity occurring between January and March 2024. ### **Claremont Temporary Housing Stabilization & Relocation Program**

On April 25, 2023 the City Council voted to allocate \$1 million in American Rescue Plan Act funding to fund the Claremont Temporary Housing Stabilization and Relocation Program. Since the program's launch, the City has provided rental assistance to over 125 households and over \$300,000 has been allocated for the first cycle alone. Applications for the second program cycle will open in May for the period of July 2024 to June 2025. # Renaming of the **Human Services Department**

The Human Services Department has been renamed the Recreation and Human Services Department. The name change was approved at the February 13, 2024 City Council meeting. The addition of the word "Recreation" to the department name emphasizes the department's oversight of the City's recreation programs, parks, and services. The new name also distinguishes it from Human Resources, a common mistake. The Recreation and Human Services Department oversees parks, recreation classes, special events, senior and youth programs and services, CBO funding, facility rentals, park ranger program, and manages the Claremont Hills Wilderness Park.

### New Playground For Lewis Park

The City is in the process of selecting new playground equipment for Lewis Park (881 Sycamore Dr.) The Parks, Hillsides, and Utilities Committee with input from residents is recommending the Birchwood Playground Design. The design has a whimsical feel to it, with colors similar to the current structure. The play structure features two slides, several climbing elements, and several panel play elements. Also included are two game tables, an inclusive spinner, and a dinosaur sculpture. The approximate cost of the Birchwood Playground set is \$140,000. The design will go to the Community and Human Services Commission for approval on March 6, 2024. Final approval will go to the City Council on March 12, 2024. Installation of the new playground should be completed by the beginning of summer 2024.

### Tree Policies and **Guidelines Manual Update**

In July, the City contracted with Dudek to review the City's Tree Policies and Guidelines Manual. The goal of the review is to recommend changes that meet industry standards while considering community character: fiscal responsibility: safety: accessibility: and compliance with Federal, State, and local regulations. Additionally, Dudek will make recommendations on reforestation goals, appropriate planting, and infrastructure-versus-tree conflicts.

To encourage public engagement, three community input meetings were held in the fall. Feedback received during the community meetings was used to guide the revisions to the Manual.

The proposed revisions to the Manual are now available for public review on the City's website. The public review period will close in late-March. Staff anticipates bringing the proposed revisions through the approval process beginning in April. For more information, please visit www.ci.claremont.ca.us/trees.

# **Gasoline-Powered**

### **Leaf Blowers Prohibited**

The use of gasoline-powered leaf blowers is prohibited in Claremont. Electric or batterypowered leaf blowers may be operated between the hours of 8 am and 6 pm seven days a week. Gasoline-powered vacuums are permitted. No leaves or other debris shall be blown into the street, sidewalk, or beyond the property line. Noise associated with the maintenance of property such as mowing, edging, and trimming can take place between the hours of 7 am and 8 pm Monday through Saturday and between 9 am and 8 pm on Sundays. Over the last few months, the Claremont Police Department has seen a rise in internet related crimes. The following two examples highlight the potential dangers related to social media use and emphasize the importance of parent and guardian supervision. Parent and guardians need to not only communicate with their children about social media safety, but also actively monitor their children's social media

In October, several underage victims met suspects through dating apps. The underage victims were coerced into agreeing to be picked up in Claremont during the day. The victims were driven to several different locations and ultimately sexually assaulted. Two of the suspects were later identified and taken into custody.

In January, a victim met a suspect on social media and was coerced into being picked up from their Claremont home in the middle of the night. Based on the victim's social media chat, the family believed the unknown suspect was going to take the victim out of state. Claremont Police Department detectives were able to determine that the victim had been kidnapped and were able to identify the suspect vehicle, which was later located in Arizona with the help of the Arizona Department of Public Safety. The suspect was taken into custody and the victim was safely returned home.

Unfortunately, situations like these illustrate how easily a child can fall victim to online predators. The Claremont Police Department would like to offer some internet safety tips to help keep you and your loved ones safe:

- Educate yourself and your children about social media safety.
- Set ground rules for social media use.
- Constantly monitor your children's online activity.
- Discuss the importance of keeping information private, such as your name, date of birth, where you live, and where you go to school.
- Avoid "oversharing" your child's life on social media.
- Never approve friend requests or add people you don't know in real life.
- Beware of "catfishing" or fake profiles.
- Turn off locations when tagging posts or posting photos.
- Advise kids/teens to never arrange to meet someone they met online.

The Recreation & Human Services Department is excited to announce a new parking permit system for the Claremont Hills Wilderness Park designed to improve the visitor experience and eliminate the need for paper and sticker permits. The system will be installed this spring. Claremont residents will simply scan their driver's license with a Claremont address at the Thompson Creek Trail parking lot on the corner of Mills Avenue and Mt. Baldy Road to receive six hours of free parking!

### **Frequently Asked Questions**

### Q: How does the system work?

A: Residents will scan their license at the parking meter in the Thompson Creek Trail (TCT) parking lot, then enter their license plate number. Park Rangers will be able to view which plates have valid permits. \*Residents receive free parking in the south lot/TCT parking lot only.\*

### Q: Will I need to apply online or in-person to obtain free resident parking?

A: No – simply follow the onscreen prompts, scan your driver's license, and enter your license plate number. It's as easy as that!

### Q: What are the benefits of the new system?

A: With this change, residents are no longer limited to two permits per household. Purchase a new car or have a rental? No problem – your ID is all you need to park. Plus, residents no longer need to apply in-person to receive this benefit.

### Q: What if my driver's license has my old non-Claremont address?

A: California Vehicle Code section 14600(a) requires that you notify the DMV within 10 days of moving to a new address. Addresses can be updated through the DMV's website or at a DMV office. Once your address has been updated, you can request a new license be mailed to you through the DMV.

### Q: What if I prefer to purchase an Annual Parking Permit for use in the northern lot?

A: Those who wish to purchase an annual permit will be able to do so online through the permit portal on our website using their license plate number. Annual Permits are \$170 and will be valid for 365 days from the date of purchase.

### **Bonita and Yale Avenue Project** La Popular, Lofts, and Coffee Shop

The redevelopment of the former Rhino Records property at the corner of Bonita and Yale Avenues continues in the spring. The La Popular CDMX restaurant, which occupies the former Rhino Records opened in November 2023. Customers can now enjoy the renovated interior of the building, which includes the exposed original wooden trusses of the historic bow truss building and the new outdoor patio. Construction is currently underway for five new loft units located over the rear portion of the building, formerly occupied by Video Paradiso. Two stories are being added over the rear portion of the building to create space for the five new dwelling units. The ground floor tenant space will be occupied by a new coffee shop and a second outdoor patio area on the north side of the building will be constructed for the new coffee shop.

### **Construction Begins on Descanso Walk Project**

Construction activities are set to begin at the former Marie Callendar's property at the intersection of Towne Avenue and Foothill Boulevard. In Fall 2023, the Claremont City Council approved the Olson Company's 56-unit townhome development that includes 12 live/work units fronting Foothill Boulevard. The Olson Company anticipates an 18-24 month construction process with the project completed in late 2025 or early 2026. The Olson Company is one of the leading residential urban infill developers in Southern California and has completed two projects in Claremont (Village Walk and Ivy Walk).

### **Preservation Ordinance**

On February 14, 2024, the Architectural Commission conducted a public hearing to consider a Preservation Ordinance for the designation and preservation of historic properties and cultural resources. The proposed ordinance would apply to all properties, structures, landscapes, and sites that are listed on the local, state, or National register for historic or cultural resources or those that qualify to be designated/listed as cultural resources. The ordinance also codifies procedures for designating properties to the City's local historic register. The Ordinance will now go to the Planning Commission for review before a recommendation is made to the City Council.
