AMERICAN RESCUE PLAN ACT (ARPA) UPDATE AND FUNDING RECOMMENDATIONS (FUNDING SOURCE: AMERICAN RESCUE PLAN ACT FUND)

<u>SUMMARY</u>

On March 11, 2021, the American Rescue Plan Act (ARPA) was signed into law by President Biden. In May 2021, The United States Department of the Treasury published the Interim final rule (IFR) describing eligible and ineligible uses of funds (as well as other program provisions), sought feedback from the public on these program rules, and began to distribute funds.

On January 6, 2022, the Treasury issued its Final Rule. The final rule took effect on April 1, 2022. The final rule delivers broader flexibility and greater simplicity in the program, responsive to feedback received during the comment process. The final rule provides state and local governments with increased flexibility to pursue a wider range of uses, as well as greater simplicity so governments can focus on responding to the crisis in their communities and maximizing the impact of their funds. Among other clarifications and changes, the final rule offers a standard allowance for revenue loss of up to \$10 million. Recipient agencies that select the standard allowance may use that amount, in many cases their full award, for general government services, with streamlined reporting requirements. The City of Claremont is estimated to receive \$8.7 million in ARPA funding, and is therefore eligible to use the standard allowance for the full amount of the City's APRA allocation.

In March 2022, the City conducted two surveys with community members and businesses, asking for input on what ARPA funding priorities they would like to see for the community. The 385 community respondents ranked thirteen potential uses of the funding in the Claremont community which were most important to them, while twenty-seven businesses provided feedback on the types of assistance that would be helpful for their businesses/organizations now and in the future.

The purpose of this staff report is to provide an update on ARPA funding options based on the Final

Rule, provide the community survey results and provide an update on the ARPA work to date, as well as receive further direction from the City Council based on recommended uses of a portion of the ARPA funds.

RECOMMENDATION

Staff recommends that the City Council ask clarifying questions regarding the proposed use of the City's American Rescue Plan Act funding, provide any additional direction to staff, and authorize the appropriation of the American Rescue Plan Act funding and implementation of the projects, programs, and expenditures described in the staff report.

ALTERNATIVE TO RECOMMENDATION

In addition to the staff recommendation, there is the following alternative:

• Request additional information.

FINANCIAL REVIEW

The City of Claremont will receive a funding allocation of \$8.7 million in American Rescue Plan Act Funds and has chosen to take the standard allowance for the full amount of the allocation. The City received its first disbursement of half the allocated funding on July 9, 2021. The second half of the funds will be released under the second disbursement one year after the first disbursement. Funds for local governments must be "obligated by" December 31, 2024, and "expended" by December 23, 2026.

On January 6, 2022, the United States Department of the Treasury issued its Final Rule. The final rule took effect on April 1, 2022. The final rule delivers broader flexibility and greater simplicity in the program, responsive to feedback received during the comment process. The final rule provides state and local governments with increased flexibility to pursue a wider range of uses, as well as greater simplicity so governments can focus on responding to the crisis in their communities and maximizing the impact of their funds.

Based on feedback provided by the community and City Council, staff has developed proposals for the use of \$4,544,300 in ARPA funds, with \$413,000 proposed to be appropriated for use in the current fiscal year, and the remaining \$4,131,300 to be included in the City's 2022-24 Budget, which will be presented for City Council adoption in June.

The allocation of the proposed \$4,544,300 in funding for the programs and projects described in this report will leave \$4,081,798 in ARPA funds unobligated. Staff will return to the City Council at a later date to recommend the allocation of the remaining ARPA funds to additional projects and programs.

The staff cost to prepare this report and administer this project is estimated at \$750 and is included in the operating budget of the Financial Services and Administrative Services Departments.

ANALYSIS

Allowed Uses of ARPA Funds under the Final Rule

The final rule delivers broader flexibility and greater simplicity in the program, responsive to feedback

received during the comment process. The State and Local Fiscal Recovery Funds Program final rule provides additional clarity and flexibility for recipient governments, including:

- Treasury has expanded the non-exhaustive list of uses those recipients can use to respond to COVID-19 and its economic impacts - ensuring states and localities can adapt quickly and nimbly to changing public health and economic needs. This includes clarifying that recipients can use funds for certain capital expenditures to respond to public health and economic impacts and making services like childcare, early education, addressing learning loss, and affordable housing development available to all communities impacted by the pandemic.
- 2. Treasury has expanded support for public sector hiring and capacity, which is critical for the economic recovery and in maintaining vital public services for communities.
- 3. Treasury has streamlined options to provide premium pay for essential workers, who bear the greatest health risks because of their service in critical sectors.
- 4. Treasury has broadened eligible water, sewer, and broadband infrastructure projects understanding the unique challenges facing each state and locality in delivering clean water and high-speed broadband to their communities.

In addition to these expansions, Treasury has greatly simplified the program for small localities many of whom have received a historic federal investment in their communities through this program - including through the option to elect a standard allowance for revenue loss rather than calculating revenue loss through the full formula.

Among other clarifications and changes, the final rule offers a standard allowance for revenue loss of up to \$10 million, allowing recipients to select between a standard amount of revenue loss or complete a full revenue loss calculation. Recipients that select the standard allowance may use that amount - in many cases their full award - for 'government services,' with streamlined reporting requirements. Recipients can use ARPA funds on government services up to the revenue loss amount, whether that be the standard allowance amount or the amount calculated amount as outlined in the final rule. "Government Services" generally include any service traditionally provided by a government unless the Treasury has stated otherwise. Some common examples, although not an exhaustive list, include:

- Construction of schools and hospitals
- Road building and maintenance, and other infrastructure
- Health services
- General government administration, staff, and administrative facilities
- Environmental remediation
- Provision of police, fire, and other public safety services and facilities (including purchase of fire trucks and police vehicles)

Ineligible Uses of Funds

Section 35.7 of the Final Rule specifically prohibits the use of Fiscal Recovery Funds for deposit into any pension fund. In addition, ineligible uses of funds would include contributions into any rainy-day funds, financial reserves, or similar funds. These types of contributions would not address the response to the COVID-19 public health emergency, as they constitute savings for future spending needs. Other ineligible uses include payment of interest or principal on outstanding debt instruments,

including fees or costs associated with the issuance of new debt; and satisfaction of any obligation arising under or pursuant to a settlement agreement, judgment, consent decree, or judicially confirmed debt restructuring plan. The purpose of the ARPA funds is to provide fiscal relief that will permit local governments to continue to respond to the COVID-19 public health emergency.

Claremont Community Input and Survey Feedback

Local governments are encouraged to use payments from the ARPA funds to respond to the direct and immediate needs of the pandemic and its negative economic impacts and the needs of households and businesses that were disproportionately and negatively impacted by COVID- 19 and the public health emergency.

- <u>Public Input</u>: Implementation of the ARPA funds reflects the importance of public input, transparency, and accountability. The Interim Final Rule established certain regular reporting requirements. These reporting requirements reflect the need for transparency and accountability, while recognizing and minimizing the burden for local governments. The Department of the Treasury urges local governments to engage their constituents and communities in developing plans to use these payments, given the scale of funding and its potential to catalyze broader economic recovery and rebuilding.
- <u>Claremont Community Survey</u>: A Community Survey was designed by staff and HdL ECONSolutions to solicit input on the following thirteen possible funding opportunities. The list below is based on the ranking provided by 385 community members, in priority order:
 - 1. Improve public infrastructure (roads, sidewalks, storm drains, etc.)
 - 2. Assist residents that need housing, food, healthcare, childcare, rent or utility help
 - 3. Public safety services
 - 4. City having the resources to continue to provide high quality services
 - 5. Recreation, parks, trails, creeks, and open spaces
 - 6. Support the recovery of local businesses
 - 7. Affordable housing options
 - 8. Traffic / Bike / Pedestrian safety
 - 9. Enhanced broadband capability, including public WiFi service
 - 11. Provide services to the homeless population

10. Provide ARPA funding to Tri-City Mental Health Authority to expand mental health services and programs

- 12. Support the work of non-profit organizations in the community
- 13. Extend/expand outdoor dining opportunities
- <u>Claremont Business Needs Survey</u>: The Business Needs Survey helped identify the negative impacts experienced by twenty-seven local businesses, as well as exploring possible ways to address these impacts and support the local business community including the possibility of an E-Gift card program and small business relief grants.

Copies of the community and business survey results are included as attachments to this report.

Proposed Use of Fiscal Recovery Funds

In response to feedback received from both the community and businesses through the ARPA survey, as well as through the City's recently concluded priorities setting process, staff has developed the

following list of recommendations for the expenditure of a large portion of the City's ARPA allocation.

Traffic Calming Measures

Staff proposes to use a total of \$500,000 in ARPA funds for the implementation of traffic calming measures, and to update the City's regulatory traffic sign inventory. The City's Engineering Division is currently in the process of studying a number of street segments and intersections to determine whether the implementation of traffic calming improvements will improve pedestrian, bicyclist, and vehicle safety. Staff proposes to use \$250,000 of these funds to complete improvements recommended by these studies.

Additionally, staff proposes to use \$250,000 to conduct an inventory of its regulatory traffic signs. Regulatory signs control traffic and set limits or give commands that are enforceable by law. Signs must also be compliant with the Federal Highway Administration Manual on Uniform Traffic Control Devices (MUTCD). The proposed inventory will identify signs currently in need of replacement, and provide data for the future maintenance and replacement of signs as they age. The funding will also provide for the replacement of existing signs that are faded, no longer reflective, or no longer meet MUTCD standards.

The proposed \$500,000 in funding for traffic calming measures is recommended to be included in the budget for 2022-23.

Community Based Organization (CBO) and Homeless Services Funding

Over the last several years, as a result of budget uncertainty, funding for the City's CBO and Homeless Services Funding Programs were eliminated. These programs were previously funded in the amounts of \$86,650 for CBO funding and \$60,000 for homeless service funding. Staff proposes to restore this funding in the total amount of \$146,650 in each of the next two budget years.

The CBO Funding Program provides grants to local non-profit organizations that deliver programs which strengthen the social, family, and/or economic fabric of the Claremont community. Past recipients of CBO funding include Claremont After-School Program (CLASP), Claremont Heritage, Claremont Meals on Wheels, Claremont Museum of Art, Community Senior Services, Inland Valley Repertory Theatre, Project Sister Family Services, California Botanic Garden, Shoes That Fit, and Sustainable Claremont.

The Homeless Services Funding Program funds organizations that assist in the prevention of homelessness and provide services to individuals currently experiencing homelessness. Past recipients of homeless services funding include the Claremont Homeless Advocacy Program (CHAP), Crossroads, Inc., Foothill Family Shelter, Inland Valley Hope Partners, and Pacific Lifeline.

Chamber of Commerce Agreement

Funding for the Claremont Chamber of Commerce to provide visitor center services through an agreement with the City was eliminated in the 2020-21 budget. In spite of the elimination of funding, the Chamber has continued to provide services, including:

• Responding to requests for information on a variety of subjects, including but not limited to, business and business opportunities, City government services and procedures, City projects, visitor and new resident information, and demographics, particularly as those inquiries relate

to business generation in the City.

- Managing and updating the Chamber website.
- Producing and distributing City, visitor, and business information materials.
- Maintaining a monthly and annual calendar of community events.
- Promoting the City and its businesses.
- Developing events, entertainment, or activities for the Village and other commercial areas with the assistance of the City and other business representatives.
- Working with the Claremont Police Department to manage the Business Watch Program.

In recognition of the City's continuing relationship with the Chamber of Commerce, staff recommends restoring funding to the Chamber in the annual amount of \$60,000 in each of the next two budget years. The proposed \$60,000 funding amount would return the City's support of the Chamber to levels consistent with those prior to the Great Recession of 2007-2009. Prior to the elimination of Chamber funding in 2020-21, the City's support of the Chamber was in the amount of \$40,000.

Accessory Dwelling Unit (ADU) Design Standards and Grant Program

The construction of Accessory Dwelling Units on existing single-family parcels is one way in which to increase the stock of available residential units in the City to address the growing demand for housing. ADUs provide lower cost housing opportunities, while also allowing the City to use new ADU construction to meet the City's Regional Housing Needs Allocation (RHNA). To support the construction of ADUs in Claremont, staff proposes the funding for the development of ADU design standards, as well as grants to incentivize ADU construction.

Staff proposes to use \$50,000 in ARPA funding to develop up to five standard ADU designs that property owners could select from in opting to construct ADUs on their properties. This program would eliminate the cost of architectural services in the ADU development process and lower the overall cost of constructing ADUs.

Staff also proposes to fund an ADU grant program, which would provide a grant in the amount of \$20,000 for a property owner constructing an ADU on their property. These grants would offset the cost of constructing ADUs and allow property owners to recoup their construction costs over a shorter period of time by renting to residents in need of housing. Staff proposes to fund grants in the amount of \$200,000 per year in each of the next two budget years.

Psychiatric Assessment Care Team (PACT) Funding

In February 2021, the City established a partnership with the Tri-City Mental Health Authority (TCMHA) to utilize a Psychiatric Assessment Care Team to respond to non-violent, non-criminal calls for mental health assistance received by the Claremont Police Department.

The purpose of the PACT is to utilize police resources more effectively and efficiently to respond to social-emotional/mental health needs of Claremont residents and/or visitors by using trained mental health professionals to take the lead on non-violent, non-criminal calls to law enforcement for assistance, including responses to persons who do not have a permanent residence. This has been achieved by mental health professionals responding to calls with a Police Officer to provide crisis response, screening, evaluation, referral, and assessment as needed. TCMHA employs two full-time mental health professionals who serve as PACT members and are stationed on-site at the Claremont Police Department.

In April 2022, the City agreed to fund half of the annual cost of the PACT Program in response to Tri-City's increasing excess liability insurance costs for the program, using ARPA funding in 2022-23. Staff proposes to fund the partnership with TCMHA for the next two budget years in the amount of \$175,000 annually.

Police Department Dispatch Center Upgrade and Radio Replacements

Public Safety agencies for 88 cities and the unincorporated areas of Los Angeles County currently use a patchwork of forty aging radio networks. This means that agencies can not readily communicate with each other, creating communications delays that waste time and imperil lives during emergency situations. The Los Angeles Regional Interoperable Communications System (LA-RICS) initiative is to replace these separate systems with a state-of-the-art network solely dedicated to emergency responders, providing day-to-day radio communications service for individual public safety agencies, enabling interoperability among member agencies and mutual aid providers, and supporting communication with regional, State, and Federal agencies in the event of a natural or man -made disaster.

In order to utilize the LA-RICS network, the City must upgrade its dispatch radio consoles and replace City-owned emergency radios with LA-RICS compatible devices. The cost of the upgrade to the dispatch radio consoles totals \$500,000, and the cost to replace 160 emergency radios for City use during emergency situations amounts to \$495,000. Staff proposes to fund the cost of these public safety communications upgrades using ARPA funding in 2022-23.

City Technology Upgrades

Staff proposes to use ARPA funding to make a number of upgrades to City technology systems, to improve public access to information, increase operational efficiency, and secure access and storage of data on the City's computer networks.

The City's website has not been updated in several years and is deficient in its organization, making it a challenge for visitors to locate information. Further, the website is lacking in accessibility features for website visitors who have disabilities. Staff proposes to use \$100,000 in ARPA funding for an overhaul of the City's website.

The City uses a number of standalone software systems supported by different vendors. These systems do not integrate seamlessly and require cumbersome processes to move information from one system to another. For example, the City uses Tyler Technologies' Inforum Gold financial system, with separate non-integrated timekeeping and cashiering systems. None of these systems can transfer information without employees performing manual data manipulation and uploads. The same situations exist for the City's business licensing, code enforcement, and permitting software. Staff is in the process of assessing the City's current software needs and determining the annual support costs for the many standalone systems it uses. Once this analysis is complete, staff proposes to implement a comprehensive solution that provides software that meets all of the City's needs and integrates in such a way as to reduce the inefficiencies that currently exist. To fund this effort, staff proposes to set aside \$400,000 in ARPA funding in the 2022-23 budget.

The City's network servers and data storage systems are also aging and in need of replacement. Staff recommends purchasing an advanced disk-based back-up system that utilizes cloud storage, which will allow essential services to continue operating in the event of a disaster where Information Technology equipment or locations become compromised. The cost of this system is \$65,000. The cost to replace four aging host servers that house virtual server systems at City Hall and the Police Department amounts to \$68,000 and is necessary to enable needed software upgrades. Staff also recommends replacing aging storage systems that host virtual server systems at City Hall and the Police Department, which would eliminate redundancy and increase reliability and capacity. The storage system replacements are anticipated to cost \$80,000, and staff also recommends the replacement of various battery backup systems at a cost of \$10,000. These back-up systems will keep essential devices operating during power outages until back-up generator power is available. The total estimated cost for these server and storage system upgrades amounts to \$223,000

Business Grant Program

One of the primary goals of the ARPA is to aid in businesses' recovery from the COVID-19 pandemic. Businesses in Claremont were impacted by County health orders which limited business activity and continue to be affected by supply chain issues and difficulties hiring and retaining employees. Respondents to the City business survey expressed a need for funding for a number of reasons, including:

- Rent and utility assistance
- Obtaining inventory and supplies
- Payroll
- Employee hiring and retention
- Marketing

Staff recommends that the City Council authorize the development of a business grant program with flexible expenditure criteria that include the categories noted above to provide additional opportunities for local businesses to reestablish themselves in the wake of the pandemic. Staff proposes to include funding in the amount of \$400,000 in the 2022-23 budget to provide grants to businesses located in Claremont to continue their economic recovery. Staff will return to the City Council with a proposal for grant program guidelines before funds are disbursed to businesses.

Business Tax Relief Program

To assist as many Claremont businesses as possible by providing tax relief, staff recommends allocating funding in 2022-23 for the rebate of the base business tax, which currently amounts to \$134.99 per business. With just under 1,500 in-town businesses that would be eligible for the program, the total cost of the program to provide tax assistance would amount to approximately \$200,000 for one year of business tax relief. Under the program, licensed businesses without a location in Claremont would not be eligible. Staff recommends that the City Council authorize funding for this tax relief program in the 2022-23 budget.

Commuter Bicycle Rebate Program

At the April 26, 2022, City Council meeting, the City Council discussed Village parking issues in relation to the proposed extension of the City's "Claremont AI Fresco" outdoor dining program. Mayor Leano expressed an interest in using ARPA funds to provide rebates for employees of Village businesses to purchase electric bicycles to use as an alternative to driving to work in the City. This proposal was intended to reduce parking demand in the Village, reduce greenhouse gas emissions, and support local businesses.

Staff believes further discussion of such a program is warranted and recommends the allocation of

\$100,000 in ARPA funding in 2022-23 for the development and implementation of a program that reduces the reliance on gasoline powered vehicles of employees who commute into or within the City to work. Among the issues to be addressed in a proposed program are eligibility requirements (employment status, income, length of commute), proposed mode of transportation (e-bike, bicycle, scooter, public transit, etc.), and rebate amounts.

If approved, staff will return to the City Council with a proposed program based on feedback and direction provided.

Stipends for Workers Providing City Services During the Pandemic

In January, staff provided an update to the City Council on the status of ARPA funding. At that time, members of the City Council expressed an interest in using ARPA funding for payments to employees who worked to serve the community during the pandemic. Staff surveyed local cities to determine if and how payments to City employees were being made using ARPA funding. In the region, payments to local government employees have been authorized using various methods of calculation, from flat amounts to percentages of pay. In recognition of City Council interest in exploring employee payments to recognize the efforts of City employees to ensure the continuity of essential City services with minimal disruptions during the height of the pandemic, staff has developed a recommendation for funding such payments using a methodology and amounts that place the City close to the median for surveyed cities.

Staff proposes that the City Council authorize stipends of up to \$4,000 for full-time public safety employees (those represented by the Claremont Police Management Association (CPMA) or the Claremont Police Officers' Association (CPOA) or covered by CalPERS under a Safety Plan), and stipends of up to \$3,000 for other full-time employees. To be eligible for the proposed stipends, full-time employees must be employed by the City at the time the stipends are disbursed, and have worked a minimum of 1,000 hours during the height of the pandemic, from March 1, 2020 to June 30, 2021. Staff proposes stipends for full-time employees who did not meet the 1,000 hour threshold to be half the maximum amount (i.e. \$2,000 for public safety employees and \$1,500 for other employees).

Staff also recommends stipends of up to \$1,000 for part-time employees who met a 500 hour threshold for hours worked from March 1, 2020 to June 30, 2021. Again, part-time employees must be employed by the City at the time the stipends are disbursed to be eligible.

Staff estimates that the cost of employee stipends would amount to \$413,000 and recommends the use of ARPA funding in 2021-22 to make payments of the stipends should they be approved by the City Council. It is important to note that the stipends would be one-time in nature and would not be reportable to CalPERS as pensionable compensation.

Timeline and Next Steps for Fiscal Recovery Funds Implementation:

- March 2022 The City conducted a Community and Business Needs survey. The results were analyzed by staff to help develop a list of priority-based funding options.
- May 2022 Presentation to City Council of business survey results and community feedback, and recommendations on ARPA funding options.
- June 2022 Place ARPA funding programs into the 2022-24 operating budget.

RELATIONSHIP TO CITY PLANNING DOCUMENTS

Staff has evaluated the agenda item in relationship to the City's strategic and visioning documents and finds that it applies to the following: Council Priorities, Economic Sustainability Plan, General Plan, and 2021-22 Budget.

CEQA REVIEW

This item is not subject to environmental review under the California Environmental Quality Act (CEQA). Under CEQA Guidelines Section 15378(b)(5), continued administrative activities and organization activities that will not result in a direct or indirect physical change in the environment are not CEQA projects. Moreover, under CEQA Guidelines Section 15378(b)(4), government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment are not CEQA projects.

The allocation of ARPA funding is an organizational activity of the government which involves the fiscal activities but does not commit to any specific project, as such, this item is not a CEQA project. Even if it was determined to be a CEQA project, pursuant to CEQA Guidelines Section 15061(b)(3), CEQA does not apply to this item because there is no potential for causing a significant effect on the environment. The allocation of ARPA funding will not have a significant effect on the environment because the action will not result in or lead to a physical change in Claremont. Therefore, no additional environmental review is needed at this time.









Q9 How much total COVID-19 relief funding has your business received?




